

End-User Terms for MySecuritas Digital ID Protection

Published: August 9, 2023

Effective: September 1, 2023

These End-User Terms for MySecuritas Digital ID Protection (“EUT”) govern your and your organization’s use of MySecuritas Digital ID Protection and any subsequent release thereof, including all associated features and functionalities, websites, mobile applications and other user interfaces (collectively “**MySecuritas Digital ID Protection**”).

1. Use of MySecuritas Digital ID Protection

- 1.1. Your license to and use of MySecuritas Digital ID Protection is governed by the terms and conditions of the agreement(s) under which MySecuritas Digital ID Protection are provided to your organization.
- 1.2. When using MySecuritas Digital ID Protection, you must:
 - i. adhere to applicable laws and regulations, including relevant privacy regulations;
 - ii. only access and use MySecuritas Digital ID Protection in accordance with instructions from your organization, and for as long as you are employed or contracted by your organization;
 - iii. only use MySecuritas Digital ID Protection for its intended purpose(s) and in accordance with any directions, instructions and limitations, including but not limited to such directions published by Securitas or Defentry AB (“**Defentry**”) in relation to MySecuritas Digital ID Protection;
 - iv. provide and maintain current, complete and accurate information for your account to MySecuritas Digital ID Protection. Your account is personal, and you may not let others use your account or share or otherwise handle your log-in credentials in a manner which puts the credentials at risk of dissemination to unauthorized individuals;
 - v. not breach, circumvent, remove or affect the technique or security systems used to protect MySecuritas Digital ID Protection;
 - vi. not act in a way that may cause MySecuritas Digital ID Protection to be disabled, overloaded, deteriorated or harmed, or in any other way that may cause Securitas or MySecuritas Digital ID Protection any damage;
 - vii. not alter, develop, reverse engineer, decompile, disassemble, attempt to derive source code, create derivative works of or make additions to MySecuritas Digital ID Protection; and
 - viii. take responsibility for any text, data, image, audio, graphics or other material which is input or uploaded by you to MySecuritas Digital ID Protection, and make sure that such information/data does not include content which is illegal, pornographic, defamatory, promotes unlawful activities or content which Securitas may consider to be in a moral or ethical grey zone.
- 1.3. The technology behind MySecuritas Digital ID Protection is managed by Securitas’ partner Defentry. By using MySecuritas Digital ID Protection, you will gain access to an online portal where you can enter information that you wish to be monitored against any associated suspicious activity on the deep/dark web. If suspicious activity is detected, you will be alerted by email or SMS. Neither Securitas, nor Defentry, is responsible for any compensation to you due to theft or misuse of your information as MySecuritas Digital ID Protection is only monitoring and alerting you of suspicious activity. You are responsible to take appropriate actions if suspicious activity is detected.



- 1.4. As a general rule of thumb, we will not monitor or investigate your specific use of MySecuritas Digital ID Protection. We however have the right to monitor and/or investigate your use of MySecuritas Digital ID Protection when deemed necessary, for example in case of a suspected breach of these EUT. If you use MySecuritas Digital ID Protection in breach of these EUT or reasonably cause us and/or our licensors or MySecuritas Digital ID Protection any harm, or if we in our sole discretion deem that your use of MySecuritas Digital ID Protection poses a security risk to us or our clients or otherwise puts us at risk of incurring damages or your use in any other aspect is considered unacceptable by us, we might need to immediately suspend or terminate your use of MySecuritas Digital ID Protection. Upon notice of such suspension or termination you must immediately stop using MySecuritas Digital ID Protection.
- 1.5. MySecuritas Digital ID Protection may not be compatible or fully functional with all devices or browsers. This means that MySecuritas Digital ID Protection might not work with your device or browser.

2. Personal data processing

- 2.1. MySecuritas Digital ID Protection monitors and processes personal data and is provided by Securitas in cooperation with Defentry. Defentry owns, manages and controls the solution for MySecuritas Digital ID Protection, including personal data processing required to deliver MySecuritas Digital ID Protection. Defentry determines the purposes and means for such processing and is data controller under applicable data protection legislation for the processing activities performed to deliver MySecuritas Digital ID Protection. Securitas will during the registration process for MySecuritas Digital ID Protection collect certain personal data from you (customer name and email address) limited to and for the purposes of identifying you as a Securitas customer and then transfer this data to Defentry as part of the service registration process. Securitas is data controller for this personal data and you can find more information on how we process that information in our [Privacy Notice](#). All other personal data will be shared by you with Defentry directly to configure MySecuritas Digital ID Protection in accordance with your needs and order. - 2.2. The personal data is handled and stored securely either within Securitas data center (customer name and email address) or within Defentry data center (such as customer name and email address, six digits of credit card numbers, company registration number, social security number or and other personal data you may share in relation to MySecuritas Digital ID Protection).

3. Intellectual Property Rights

All rights pertaining to MySecuritas Digital ID Protection including any software applications therein, and its contents, including copyright and any other intellectual property rights pertaining to the development of, the basis for and the compiling of contents, in MySecuritas Digital ID Protection, even after installation on personal computers, mobile handsets, tablets, wearable devices and/or other devices, are owned or licensed by Securitas, Defentry, and/or our licensors. Copyright notices and any other notices on ownership in MySecuritas Digital ID Protection or relating documentation must be preserved and may not be removed or altered.

4. Amendments

Securitas reserves the right to amend or change these EUT and/or MySecuritas Digital ID Protection at any time without notice. When we update these EUT, the “Effective as of” date above will be updated to reflect the date of the most recent version. Your continued use of



MySecuritas Digital ID Protection constitutes your acceptance of the modified EUT. We encourage you to periodically review these terms to ensure you are in compliance.
